The GeoVista Credit Union awards three scholarships in remembrance of Thomas A. McCorkle, Walter "Jack" Jenkinson and Eddy E. Rogers to three deserving high school seniors graduating in 2020. The scholarships are presented in the month of May prior to the end of the school year.

<u>Eligibility</u>

- 1. Applicant must be the **primary member of an account** with GeoVista Credit Union.
- 2. Graduating seniors must be accepted in an accredited college, university, or vocational school as a full time degree-seeking student.
- 3. The student must have maintained at least an overall grade point average (GPA) of a C from the current high school.

How to Apply

- 1. Application forms are available upon request from any of our GeoVista Credit Union locations. The application is online and may be printed from our website <u>www.geovistacu.com</u>.
- 2. A copy of the high school transcript is required along with the application. The transcript will be used to establish an adequate representation of scholastic abilities.
- 3. The Scholastic Aptitude Test (SAT) or American College Testing (ACT) scores **must** be listed on the application.
- 4. The complete package with all necessary information **must** be postmarked no later than **April 1, 2020** and mailed to:
